

PRC AUTHOR CHECKLIST AND GUIDELINES

In order to curtail publishing costs and produce your publication in a timely manner, we ask that you complete the following checklist **before submitting your revised manuscript for final PRC approval.**

- **Do not number headings and subheadings.** Headings and subheadings should not have identifying numbers such as 2.1 or 3.1.2 or 6.2.1.3 and should not be referred to by these kinds of number (for example, do not refer to a section by saying “see Section 5.2.” **If headings have already have such numbers attached, remove them and any references to them.** Without resorting to numbers, however, please make it clear what the relative hierarchy of headings and subheadings is: which subheadings fall under which larger headings. You can flag this through the relative size of headings/subheadings or by using bold or italic font.
- **Obtain copyright permission**—IFPRI cannot allow copyright infringement in its publications. If a manuscript contains tables, figures, maps, etc. taken from non-IFPRI publications, the authors **MUST** obtain permission to use those materials. If the item will appear in the IFPRI publication in substantially the same form as in its original outlet, whether print or online, then it is considered “copyrighted material.” Thus, a figure, table, or other graphic reproduced from another source is considered copyrighted material. This applies even if the IFPRI author has adapted or altered the graphic in some way: removing a column from a table, changing a heading, etc. A text excerpt of a page or more is also considered copyrighted material. **Proof of permission must be attached to your final submission to the PRC.** (See *Permission Request Form* below. Fax, email, or mail to the appropriate copyright holders.)
- **Provide all tables, figures, maps, and equations in the correct form:**
 - *All tables, figures, and maps should be comprehensible if rendered in black-and-white rather than color (color versions of the graphics can be posted on the web, if necessary).*
 - All tables must be Word or Excel tables.
 - All maps must be either high-resolution EPS files (first choice) or high-resolution TIFF files (second choice).
 - All figures other than maps (graphs, bar charts, pie charts, etc.) must be either Excel files or high-resolution EPS or TIFF files.
 - Equations must be created using MathType (first choice) or by simply typing them in as you would regular text, using numbers, math operators, sub/superscripts.
 - *Do not provide these elements as embedded images or in any other forms apart from those listed above.*
 - Make sure that each table or figure can be understood on its own, without reference to the main body of the publication: this means all symbols or abbreviations should be fully explained within the table or figure.
 - All tables and figures must have notes identifying their source(s).
 - Adhere to standard punctuation for table and figure titles: capitalize only the first word, any proper nouns, and the first word after a colon.
- **Include the front matter:** Table of Contents, Foreword, and Acknowledgments pages
- **Ensure that all references include the following information:**
 - Author
 - Year of Publication
 - Title (article, chapter, book, report, presentation, etc.)
 - Title and editor of overall volume (where appropriate)
 - Journal Title (where appropriate)
 - Journal Volume, Issue, and page number (where appropriate)
 - Conference Title, date, and location (where appropriate)
 - City/(State)/Country
 - Publishing agency/Organization Name
 - URL and access date (where appropriate)

Also, ensure that in-text citations have a corresponding reference in the reference list and vice versa.

- **Review word usage and style:**
 - Do not hyphenate words such as *agroecological dataset, multisectoral, policymaker, etc.* (For a complete list of correct word usage, see pp.6–7 of the Style Manual Highlights www.ifpri.org/sites/default/files/stylemanualhighlights.pdf).
 - Use Standard American English throughout (*labor* not *labour, organization* not *organisation, etc.*).

Note to Copyright Holder: The reproduced graphic/text may be adapted from its original form; the reproduced graphic/text will be included in both print and online versions of IFPRI's publication; the print version will be partly for sale and partly available free of charge (i.e., a significant number of copies will be distributed by both means); and the online version will be available for free download from IFPRI's website

Copyright Requirements for Publication

Before any IFPRI work can be published, authors MUST obtain permission to use all copyrighted, non-IFPRI materials within the work. IFPRI cannot allow copyright infringement in its publications.

To qualify as “copyrighted material,” it must appear in the IFPRI publication in substantially the same form as in its original outlet, whether print or online. Thus, a figure, table, or other graphic reproduced from another source is considered copyrighted material. This applies even if the IFPRI author has adapted or altered the graphic in some way: removing a column from a table, changing a heading, etc. A text excerpt of a page or more is also considered copyrighted material.

If, on the other hand, an author uses information from an outside source’s graphic (data from a table’s cells, for instance) but does not reproduce the actual graphic in some form or other, then this is not considered reproduction of copyrighted material. In the same way, a text excerpt/quotation of under a page is not considered a potential copyright violation. In these cases, all that is required is a standard academic citation of the original source.

In cases where copyrighted material is being reproduced, the author must seek permission from the publisher of the original source. The author should fill out the Copyright Request Form and submit it to the publisher.

If the publisher agrees to IFPRI’s terms, then production can proceed with the copyrighted material included, along with a citation and any credit lines the publisher might request. If the publisher declines to grant permission, then the copyrighted material must be removed from the IFPRI publication.

The publisher might also offer a qualified permission, in which case the correct response depends upon the permission’s precise terms:

- If the publisher grants permission, but with the sole condition that the graphic/text not be adapted but instead be reproduced in its original form, then it is up to the authors to decide whether to use the original material or to drop it from the publication.
- If the publisher grants permission but requires a fee, then it is up to the authors to decide whether to pay for the graphic/text or to drop it from the publication. The authors are responsible for paying all permission fees.
- If the publisher grants permission to reproduce the graphic/text in the print version of the publication but not the online version, or vice versa, then the graphic/text must be removed from the IFPRI publication.
- If the publisher places a time limit on the permission—we have permission to include it in our publication for the next five years, say, but not after that—then the graphic/text should be removed from the IFPRI publication.
